The Fixed Forever Warranty – General Terms

The Fixed Forever Warranty does not apply to routine scheduled maintenance items. The “Warranty Record” is not assignable and is for exclusive benefit of the customer and vehicle identified herein.

In the event that an automobile mechanical service rendered by Tuffy Auto Centers of Richmond fails to perform satisfactorily within the specified period from date of invoice, then the same service as covered by original invoice will be rendered to the degree necessary to correct the faulty performance, unless the invoice is noted to show that the customer declined to authorize certain specified labor, parts or materials as required for satisfactory performance.

Tuffy Auto Service Center, rendering the original service, will handle corrections, without any additional charge for parts.

Customer Obligation

We’d like you to make Tuffy Auto Service Centers your first choice for service. In order to exercise the Lifetime Warranty Parts, you are obligated to:

- Return your vehicle needing repair to the original servicing Tuffy center
- Provide the shop with a copy of the original Repair Order showing that Tuffy had earlier replaced the warranty-eligible parts

What is Not Covered

- Failure due to: accident or collision; misuse, abuse or modification; chemical fallout; salt, hail, or other environmental conditions including natural disasters; marine use; improper installation; installation of an incorrect part; and damages caused by other faulty parts.
- Parts under manufacturer's recall for a related problem.
- Parts installed on vehicles used off-road or for racing purposes.
- Parts installed on a commercial-use vehicle after 90 days.
- Used or salvage parts.
